An Act for authorizing the Remission of Rent and Assessment due from certain Pastoral Lessees of the Crown in the Province of South Australia.

[Assented to, 16th March, 1866.]

WHEREAS it is desirable to authorize the Governor to remit Preamble.
certain rent and assessment due from the pastoral lessees of the Crown hereinafter mentioned—Be it therefore Enacted, by the Governor-in-Chief of the Province of South Australia, by and with the advice and consent of the Legislative Council and House of Assembly of the said Province, in this present Parliament assembled, as follows:

1. It shall be lawful for the Governor in Executive Council, within Governor may remit rent.
four months from the passing hereof, to remit payment of rent or rent and assessment (as the case may be) due from the pastoral lessees of the Crown in the said Province, enumerated in the Schedules A, B, and C, hereunto annexed, who may request such remission within three months from the passing hereof, by written notice to the Commissioner of Crown Lands and Immigration, so nevertheless that no such remission shall exceed the amount of rent or rent and assessment hereinafter mentioned, that is to say, in respect of the lessees whose names and the numbers of whose leases are mentioned and described in the said Schedule A, six months' rent or rent and assessment; and in respect of the lessees whose names and the numbers of whose leases are mentioned and described in the said Schedule B, twelve months' rent or rent and assessment; and in respect of the lessees whose names and the number of whose leases are mentioned and described

described in the said Schedule C, eighteen months' rent and assessment: Provided that any of such pastoral lessees who shall request or accept any benefit or advantage under this Act in respect of any leases contained in any of the schedules shall not be entitled to any benefit or advantage under or by virtue of any Act made or to be made and passed in the present Session of Parliament, for the purpose of amending the laws relating to the leasing of the Waste Lands of the Crown for pastoral purposes, in respect of the same or any other leases contained in the same Schedule, nor until such lessee or lessees shall personally, or by an authorized agent, have made a declaration in the words or to the effect contained in the Schedule hereto annexed marked D.

Short title.

2. This Act may be cited as "The Remission of Rent Act, 1865-6."
